

Matters to be Considered and Agreed Upon when Applying for
Special Loan for Welfare Fund (General Support Funds)

***Entry example**

[Matters to be considered]

- 1 **This application form is for providing a loan based on the Welfare Fund Loan System.**
- 2 The borrowing period for living support expenses shall be within three months from the month from which the applicant wants to borrow the fund.
- 3 The limit amount for the loan for the living support expenses shall be 200,000 per month for a household with two or more persons and 150,000 per month for a single-person household.
- 4 The deferment period for the loan for the living support expenses shall be within twelve months after the final loan date.
- 5 The redemption period for this loan shall be within ten years after the expiration of the deferment period.
- 6 This loan shall be free of interest.
- 7 If the loan is not repaid until the redemption period, overdue interest of 3.0% a year on the overdue principal shall be required to be paid.
- 8 If a person who has borrowed this fund finds employment, any other public benefit or loan is decided to be given to him/her, or the conditions of his/her household are significantly changed during the borrowing period, he/she must immediately notify this Council of it.
- 9 If the borrowed money is used for purposes other than the intended purpose, temporary repayment of the loan shall be ordered or the loan shall be terminated.
- 10 Upon receiving the application for the loan, this Council may make inquiries to Japan National Council of Social Welfare, other Prefectural Social Welfare Councils and related organizations including municipalities to confirm facts pertaining to matters described in the application for the loan and the attached documents.
- 11 If the loan has been decided to be given, the applicant for the loan shall seek to obtain self-reliance early by making use of the loan for self-reliance and rehabilitation and receiving continuous consultation support by the Social Welfare Council.
- 12 If the applicant has no house when applying for this loan, he/she is required to apply for the Housing Security Benefit provided by municipalities to ensure that he/she is expected to find a house. Any applicant who has no house is required to receive support to obtain a house.
- 13 If the applicant has made an application to obtain a house according to 12, the loan for the living support expenses shall be granted to him/her after he/she has moved into a new house and submitted a "Copy of the Notice of Determination Regarding Granting of Housing Security Benefit" issued by the municipality.
- 14 If any false statement is found in the contents of the application, the loan may be immediately terminated and the applicant may be required to redeem the loan in a lump.
- 15 Loan of this fund shall be decided after conducting an examination. Therefore, as a result of the examination, your expectation cannot be met. Note that, if the application is not approved as a result of the examination, we will not provide the applicant with the reason.
- 16 Regardless of whether the loan is approved or not, all of the submitted application documents shall not be returned to the applicant.

[Matters to be agreed upon]

- ☐ I approve the above-described matters to be agreed upon and apply for the Welfare Fund Loan.
- ☐ After the loan is provided, I will receive continuous consultation support by the Social Welfare Council to seek to obtain self-reliance early.
- ☐ I agree that my personal information entered in the application form shall be provided to third parties to the extent necessary for this system.
- ☐ I agree that your Social Welfare Council shall make inquiries to Japan National Council of Social Welfare, other Prefectural Social Welfare Councils and related organizations including municipalities to be provided with my personal information to the extent necessary for the loan.
- ☐ I am not currently a welfare recipient.
- ☐ I will not use the borrowed money for purposes other than the intended purpose described in the application form.
- ☐ Everyone except me in the household does not borrow money from this special loan system.
- ☐ I and other persons in my household are not organized crime group members. And we will not become organized crime group members during the borrowing period.
- ☐ I agree that your Social Welfare Council shall ask the government and public offices to provide you with information on relevance to organized crime group members concerning me and my household members.
- ☐ If the application is not approved as a result of the examination, I agree that the reason shall not be disclosed.
